#### **VII. Subcontracts**

**A.** The Contractor is responsible for the hiring and wages of any and all subtractors required for the completion of Work. Subcontractors must have any required training and/or licenses for the completion of Work.

**B.** The Contractor is responsible for any and all injuries caused to subtractors during the completion of Work.

**C.** The Contractor will be held liable for any damage to the Property by subcontractors, or by any and all negligence by subcontractors to complete the Work to the specifications outlined in Section II.

### VII. Changes to Work

**A.** The Owner is not required to pay any additional fees caused by unauthorized changes to the Work outlined in Section II.

**B.** Any changes, alterations, or modifications to the Work will require a separate contract for completion. The Contractor must complete all Work by the required dates and may not delay construction if both parties do not provide written agreement to an amended contract.

#### **VIII. Warranty**

**A.** The Contractor guarantees any structures, furnishings, and other materials involved in the Work for a period of [Number] years.
